Welcome to the 2020-2021 school year. Our Extended- Care program this year will offer before and after care. Before School Care will be offered from 7:00 a.m.-7:45 a.m. and After School Care will be offered from 3:05 p.m. - 6:00 p.m.

The registration fee for extended care for 2020-2021 is **\$40** per family. We will be accepting this payment through our FACTS Management system. The daily rates for an individual student will be \$6.00 per hour. Rates for multiple students will be \$ 6.00 per hour for the first child and \$4.00 per hour for each additional child.

Please have all the attached Extended-Care paperwork completed upon arrival on Registration Day. We will also need a copy of the family health insurance card in case of an emergency. This will help to expedite the registration process.

It is important that you read over our pick-up policies. Please be informed regarding our policies relating to after school extra-curricular activities. Our policies help to assure the safety of your child.

**Sign Out:** When picking up your child, a signature along with the pick-up time picked is required. If your child has been put on the roll and you do not sign them out, we assume they are here until 6:00 p.m. and you will be charged accordingly.

**Pick-Up:** **Children must be picked up no later than 6:00 p.m. each evening.** Please be considerate in picking up your child on time, as we too, have evening obligations to meet. The fee for late pick-up will be \$1.00 per minute after 6:00 p.m. **Please call the extended care phone number when you have arrived on the property.**

**Extended Care staff is not responsible for transporting your child to extra-curricular activities that are not school related events (sports, scouts, and church activities). Persons indicated on your child pick up list may sign your child out for these after school activities.**

**Discipline:** All children enrolled in before and after school care will be expected to follow rules established by the staff for the safety and smoothness of the program. Children with persistent behavior problems will be asked to leave the program. Teachers are committed to positive reinforcement. If a major discipline problem occurs, you will be contacted.

## **Extended Care Missions and Beliefs:**

Our mission is to provide a safe and comfortable environment for our children. We will instill the fundamental beliefs of the Roman Catholic faith. Our students will continue to grow physically, mentally, spiritually and socially in the Extended Care Program.

## **Extended Care Staff Responsibilities:**

- \*Having the extended care room ready for arriving students
- \*Making sure a healthy snack is provided.
- \*Facilitating student attention on homework assignments during the designated time. The staff will not be responsible for corrections or completion.
- \*Creating a fun and stimulating environment for various age levels.
- \*Making sure all children are safely picked up by designated parent or guardian 18 years and older.
- \*Maintaining the room and having it ready for next day activities
- \*Securing the school and Parish facility at the close of the day.
